Satya Arts Association (SAA) and the above named Market Vendor agree as follows:

Satya Art Association contracts the Market Vendor to provide **one retail operation** to be located in **The Meena Bazaar** at the Better Living Centre at **Masala! Mehndi! Masti! 2009**

DATES: July 24th to July 26th 2009

TIMES: Friday 6pm – 11 pm, Saturday 12 pm-11 pm, Sunday 12 pm-7:00 pm

LOAD-IN: Friday 4-6pm

LOCATION: The Better Living Centre Building, Exhibition Place

The Market Vendor agrees to pay SAA a fee of:

- **\$1,000.00** if booked and paid for **before May 31, 2009**
- **\$1,100.00** if booked and paid for **between June 1, 2009 to June 30, 2009, and**
- **\$1,250.00** if booked and paid for **between July 1, 2009 to July 23, 2009**

for one 10ft x 10ft booth, payable immediately upon signing.

Payment can be made by cash, money order or certified cheque, payable to Satya Arts Association.

Terms and Conditions

- Music is not to be played by vendors unless granted approval by event programmer.
- Signage must not be larger than 2' x 6' and must obtain approval by the event programmer on setup day.
- Vendors must bring their own decor. Please bear in mind that it must be colorful and festival oriented.
- SAA will not be held accountable for weather conditions that hinder or prevent the vendor from proceeding with their involvement at the festival; or which hinders the number of attendees at the festival.
- Should the vendor not arrive on time (more than 15 minutes late) for their setup, a penalty will be levied of \$100.00.
- SAA reserves the right to remove any Market Vendor that does not follow Satya Arts Association/Exhibition Place guidelines.
- The Market Vendor listed in this said contract will be liable for any damages to the booths
- Fees are non-refundable.
